Medication Administration Records (MAR)(Pilot)(Add-on Pricing)

- For agencies which already signed up for the beta program - \$10 per year per individual July 1, 2009 to June 30, 2012.
- For agencies not in the beta program - \$14 per year per individual July 1, 2009- June 30, 2012.

Personal Finance (Pilot)(Add-on Pricing)

- Included for July 1, 2009 to June 30, 2011.
- \$12 per year per individual for July 1, 2011 to June 30, 2012.

- No Minimum annual fee - Agencies in Montana Disabilities Services Division and Department of Public Health & Human Services.
- On-Site Training Costs - \$1000 per day or call to discuss.
- Therap may reduce initial period prices to reflect efficiencies in marketing, training or other startup costs and where an initial user is in a referencable sector that may help Therap develop local and state compatibility.
- If an agency uses Therap for 100% of its individuals, then future individuals will be at the same price package. Otherwise, agencies may add people during the first year of service at the same pricing structure they started with, but individuals added after 12 months will be at future price structures.
- Invoices must be paid within 60 days to maintain discount level and to maintain prices from this price sheet.
