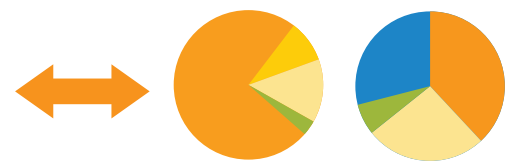
Flow of Outcome Data

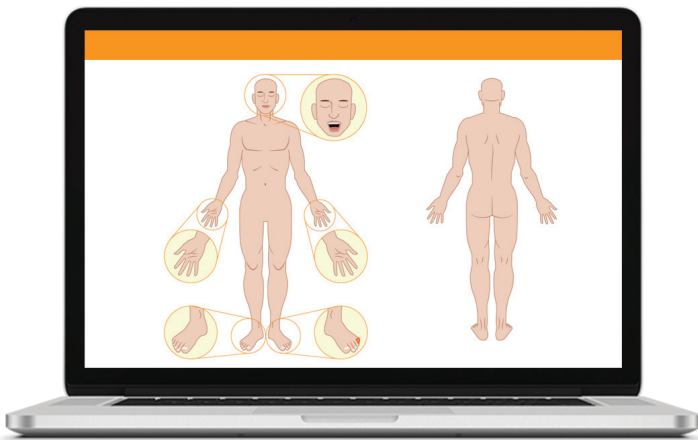
Incident Management & Reporting

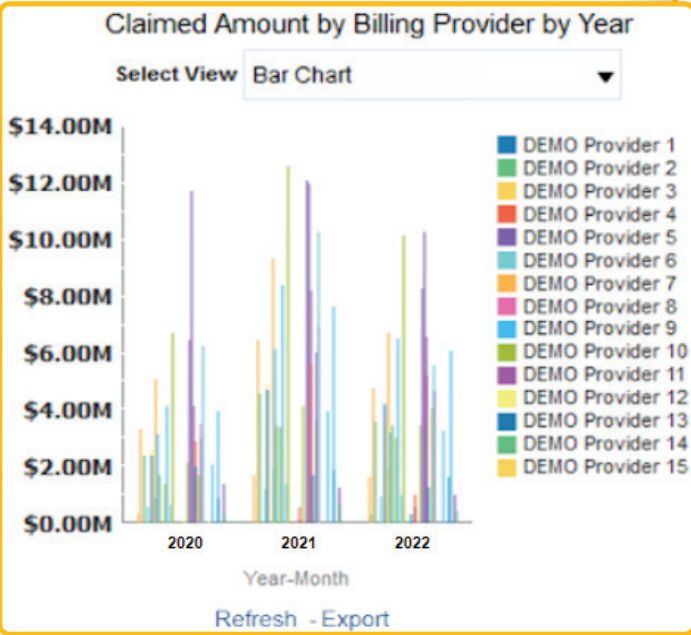
